## **Research Interest**

My main research area involves inequality between countries, regions, and individuals. In particular:

- I have investigated the dynamics of inequality in income and wealth among countries of the world, European regions and Italian provinces through quantitative nonparametric methods and spatial econometrics and developed some theoretical models to explain the persistence of inequality observed in the last 40 years;
- I have studied the dynamics of inequality in the well-being and wealth of individuals, as well as of social mobility, with a particular focus on the United States and Italy;
- I have investigated the effects of migration on the welfare and income of Italian regions.

This is joined by a recent field of investigation concerning the role of multinationals (both from advanced and emerging countries) in promoting the socio-economic development of the countries in which they are operating, with particular attention to their policies of Responsible Management and respect for human rights.
